



Clinical Postdoctoral Fellowship in School Based Mental Health and Special Education

Summary

The Baker Center for Children and Families (previously Judge Baker Children's Center), a Harvard Medical School Affiliate, is accepting applications for a clinical postdoctoral fellowship position at the Manville School, a therapeutic day school located at The Baker Center for Children and Families. The Manville School is an out of district placement for students from kindergarten through 10th grade who experience emotional, neurological, or learning difficulties that have impacted their ability to succeed in previous school settings. Manville has a strong tradition of providing innovative educational programming, behavioral interventions, and evidence-based clinical services. This integration of services provides students with challenging needs the opportunity to experience academic success, social development, and emotional growth.

The clinical postdoctoral fellow will carry a caseload of up to 8 students enrolled in the Manville School. The fellow will serve as their student's clinician and case manager, which will include the delivery of individual therapy, consultation with classroom teams, family therapy/parent training (as applicable), and collaboration with both internal and external support services and providers. The fellow will also work with classroom teams to deliver Second Step, an evidence-based social-emotional learning curriculum. As case manager, the fellow will lead any interdisciplinary team meetings, service-planning meetings, or parent-teacher conferences for the student. As part of the fellow's role as a psychologist at Manville, training will also include the assessment and evaluation of students requiring 3-year reevaluations to determine continued eligibility for special education services. Assessments are comprehensive and include psychological evaluation and diagnostic impressions. The postdoctoral fellow will receive training and supervision in evidence-based interventions for children and adolescents, including potential certification in the Modular Approach to Therapy for Children (MATCH). Applicants will also receive supervision consistent to meet Massachusetts psychology licensure requirements in the course of the fellowship year. Appointment as a fellow at Harvard Medical School is available for the qualified successful applicant.

Essential Duties and Responsibilities

- Maintaining a diverse caseload of approximately 8 students, providing weekly individual therapy as outlined by their IEP
- Implementing an evidence-based social emotional curriculum within an assigned classroom
- Conducting diagnostic and psychoeducational assessments
- Providing consultation and crisis intervention as needed
- Coordinating care with families, community-based providers, government agencies and other collaterals as appropriate
- Leading interdisciplinary team meetings and attending all IEP meetings for your caseload
- Co-supervising graduate level trainees

Qualifications and Skills

Candidates must meet all the following requirements:

- Completion of a PhD/PsyD/EdD (or foreign equivalent) in Clinical, Counseling, or School Psychology from an accredited academic program
- Completion of an APA- or CPA-approved internship
- Clinical training and experience with evidence-based practices and interventions

- Clinical training and experience with comprehensive evaluations and report writing
- A commitment to culturally responsive care

Strong applicants will have:

- Experience supervising or training clinicians in evidence-based practices
- Clinical training and experience with risk assessment and crisis management
- Excellent interpersonal, organizational, and communication skills (verbal and written)
- Strong computer skills
